Our stand attracted a significant number of visitors, with around 90 students stopping by during the 3-hour event. The interest in our programme was evident, as 43 students have already pre-registered. We plan to seek tentative expressions of interest from you, our partner agencies, around the end of June.

ACKNOWLEDGING IRD H&S REPS ACHIEVEMENTS

In November, the inaugural cohort for the new Public Service Early in Careers (EiC) Certificate successfully completed the program. Among the 25 participants, 22 attained their NZQA Level 3 accreditation, with four being Health and Safety Reps from Police, WorkSafe and Inland Revenue. The Inland Revenue's Health and Safety team publicly celebrated and congratulated their representatives, Maarten Bazuin and Suzie Allum, for their accomplishments by featuring them in an IRD article for World Day for Safety and Health at Work 2024 (full article available here). After finishing his GHSL EiC training, Maarten said he has a better understanding and awareness of health and safety and how to manage them. He said, 'Employees and employers should exchange information and ideas about risks to health and safety, and measures that can be taken to eliminate or reduce those risks'. Our congratulations to Maarten, Suzie, and the rest of the first cohort for passing their NZQA Level 3, with a special mention to the other successful H&S Reps, Alannah McLean and Craig Yorston.

DE-ESCALATION TRAINING UPDATE FOR PUBLIC SECTOR WORKERS

When WorkSafeReps ceasing trading in January 2023, our 3-hour online de-escalation workshop for front-line public-sector workers was discontinued. This workshop had been specifically designed for workers who interact with the public either over the phone or in controlled work environments. I'm delighted to say that the New Zealand Council of Trade Unions (NZCTU) recently reached out to us to collaborate on updating and re-introducing the workshop. This will deliver a cost-effective, travel-free and impactful course for workers. The course will continue to be priced at \$150 +GST per person, focusing on providing workers with the skills to identify common signs and verbal cues, de-escalate situations and safely disengage.
